

# Synthetic Wombs Privacy Policy

Protecting your privacy is important to Synthetic Wombs.

This Privacy Policy explains how Synthetic Wombs collects, uses, and discloses the personal information you may provide while using syntheticwombs.com (the "Website") and the services provided through any of the Website. It is always your choice whether or not to provide personal information through the Website. Any personal information you provide will be treated in accordance with this Privacy Policy.

## Your Consent

1. By using or submitting information to this Website, you consent to Synthetic Wombs' collection, use, and disclosure of your personal information in accordance with this Privacy Policy. If you do not agree with this Privacy Policy, you may not use or submit personal information to the Website.

## Information Automatically Collected

**4. Your Personal Information** - During your use of the Website, you may be asked to voluntarily provide personal information (such as your name, e-mail address, and address) for communications with you. If you choose not to provide certain requested personal information, you may not be able to use certain features of the Website.

**5. Use of Your Personal Information** – Synthetic Wombs may use your personal information to contact and correspond with you, respond to your communications, provide services to you, facilitate and enhance your use of the Website, and as otherwise permitted by law. Additionally, Synthetic Wombs may keep a record of all communications with you.

Synthetic Wombs uses third-party advertising companies to serve ads when you visit its Website. These companies may use information (not including your name, address, email address or telephone number) about your search queries and visits to the Website and other websites in order to provide advertisements about goods and services of interest to you. You should be aware that if you voluntarily disclose information online (whether through Synthetic Wombs' services or any other service available online), personal or otherwise, that information can be collected and used by others. Synthetic Wombs allows its users to send articles or links by email to other parties who may be interested in them. Synthetic Wombs does not retain any email addresses of either the sender or recipient of such articles or links after they are sent.

**6. E-mails from Synthetic Wombs** - If you register as a Synthetic Wombs member, then Synthetic Wombs may send to you, from time to time, e-mail or other communications containing information about Synthetic Wombs and other matters that Synthetic Wombs believes will interest you. At any time you may ask Synthetic Wombs to stop sending you e-mail by sending your request by e-mail to [info@syntheticwombs.com](mailto:info@syntheticwombs.com). Also, each e-mail Synthetic Wombs sends to you will tell you how to decline further unsolicited e-mail.

**7. Disclosure of Your Personal Information** – Synthetic Wombs may disclose your personal information in the following circumstances and as otherwise permitted by applicable law:

**a. Disclosure to Authorizing Persons** - If you use the Website on behalf of another person or organization (such as your

employer), Synthetic Wombs may provide your personal information to that authorizing person/organization. Synthetic Wombs has no control over the use of your personal information by the authorizing person/organization, and that use is not subject to this Privacy Policy.

**b. Disclosure to Synthetic Wombs Business Associates** – Synthetic Wombs may provide your personal information to its affiliated businesses, advertisers, or suppliers and service providers for use in connection with the operation of the Website. Synthetic Wombs may also disclose your personal information to service providers who analyze website use. Synthetic Wombs requires its affiliated businesses, advertisers, suppliers and service providers to agree to use your personal information only for the purposes for which it is provided to them, and to protect the privacy of your personal information in a manner that is consistent with this Privacy Policy.

**c. Disclosure in Business Transfers** - Synthetic Wombs may be involved in the sale or transfer of some or all of its business. As part of that sale or transfer, Synthetic Wombs may disclose your personal information to the acquiring organization, but will require the acquiring organization to agree to protect the privacy of your personal information in a manner that is consistent with this Privacy Policy. Synthetic Wombs shall assume no liability for the acquiring organization's use and disclosure of your personal information. If at any time you do not wish Synthetic Wombs to disclose your personal information as part of the sale or transfer of some or all of its business, please send your request by e-mail to [info@syntheticwombs.com](mailto:info@syntheticwombs.com).

**d. Law Enforcement and Legal Disclosure** - Synthetic Wombs may disclose your personal information to a government institution that has asserted its lawful authority to obtain the information or where Synthetic Wombs has reasonable grounds to believe the information could be useful in the investigation of unlawful activity, or to comply with a subpoena or warrant or an order made by a court, person or body with jurisdiction to compel the production of information, or to comply with court rules regarding the production of records and information, or to its legal counsel. Synthetic Wombs has no control over, or liability for, those persons' use and disclosure of your personal information, and that use and disclosure is not subject to this Privacy Policy.

**8. Depersonalized Information** - Synthetic Wombs may use personal information to create non-personal information regarding the use of the Website and related services. Synthetic Wombs may then disclose that non-personal information to other persons and permanently archive that non-personal information for future use.

**9. Business Contact Information** - To the extent permitted by law, the provisions of this Privacy Policy concerning "personal information" do not apply to information which enable you to be contacted at a place of business, such as your job position or title, business address, business telephone number, business fax number and business e-mail address.

**10. Location of Information** - Synthetic Wombs will store and process your personal information in Vancouver, British Columbia, Canada.

**11. Securing Your Information** - To help protect the confidentiality of your personal information, Synthetic Wombs employs reasonable security safeguards appropriate to the sensitivity of the information. Nevertheless, security risks cannot be eliminated and Synthetic Wombs cannot guarantee that your personal information will not be used or disclosed in ways not otherwise described in this Policy.

**12. Accessing Your Personal Information** - You may request access to your personal information and information about Synthetic Wombs' collection, use and disclosure of that information by sending your request by e-mail to [info@syntheticwombs.com](mailto:info@syntheticwombs.com). Subject to certain exceptions prescribed by law, you will be given reasonable access to your personal information within a reasonable time, and to amend it as appropriate. Synthetic Wombs attempts to keep its records as accurate and complete as possible.

**13. Other Websites** - The Website may contain links to other sites or internet resources. When you click on one of those links you are contacting another website. Synthetic Wombs has no responsibility or liability for or control over those other websites or their collection, use and disclosure of your personal information.

**14. Terms and Conditions** - The [Synthetic Wombs Terms and Conditions](#) agreement contains important provisions, including provisions disclaiming, limiting or excluding Synthetic Wombs' liability for your use of the Website and provisions determining the applicable law and exclusive jurisdiction for the resolution of any disputes regarding the Website. Each of

those provisions applies to any disputes that may arise in relation to this Privacy Policy or Synthetic Wombs' collection, use and disclosure of your personal information, and shall be of the same force and effect as if they had been reproduced directly in this Privacy Policy.

*15. Former Users* - If you stop using the Website or your permission to use the Websites is terminated, Synthetic Wombs may continue to use and disclose your personal information in accordance with this Privacy Policy.

*16. Policy Changes* - To accommodate changes in the Website, changing technology, and legal developments, this Policy may be changed from time to time at Synthetic Wombs' sole discretion and without any prior notice to you. New versions of this Privacy Policy will be posted here. Synthetic Womb's collection, use and disclosure of personal information will be governed by the version of this Privacy Policy in effect at that time.

Your continued dealings with Synthetic Wombs or your use of the Website subsequent to any changes to this Policy will signify your consent to the collection, use and disclosure of your personal information in accordance with the changed Privacy Policy.
